TAX tip!

As we near the end of the calendar year we look forward to the holidays and with some trepidation the dreaded end of a tax year. Be prepared and then *fear not*, for congress has rounded off the sharp edges in the "American Taxpayer Relief Act of 2012". If you have an IRA, and are 70.5 years of age or older, you can reap a bit of relief by making a charitable contribution under the provisions of this act directly from the IRA to the charity without increasing your Taxable income; in addition this amount will count toward your MRD (Minimum Required Distribution) if you are subject to such.

This procedure, entitled a "Charitable IRA Rollover", allows you to make tax-free transfers (up to \$100,000 per year) directly from your IRA to charities without listing this as income on your tax form and still satisfying the need for a MRD of equal amount.

Certain limitations apply and you are strongly advised to review your situation with your financial advisor to assure that this procedure applies in your situation. Note well:

- You must be at minimum 70 and one half years of age when the transfer occurs.
- Total gifts cannot exceed \$100,000 per year per IRA owner.
- Gifts must be made directly from the IRA to the charity.

Gifts must be outright; not to a charitable gift annuity or to fund a charitable remainder trust.

Once again, you should review your situation with your tax advisor to assure you are eligible for this procedure, and if you are, everyone wins, you and our wonderful Parish.
